### **Pre-qualifying requirements (PQR):**

After evaluating the Technical bid, the price bid of successful bidders will be open, who will meet the PQR as given below:-

1. The bidder should have successfully executed/completed similar works like assistance in Operation/Maintenance works in Govt./PSU/IPPS/Reputed organization during last Seven (07) years ending the last day of the previous month and the executed value of the job should be either of the following :-

(a) In case of single contract in a year, completed/executed value should not less than **Rs.151.17 Lakhs.**

**OR**

(b) In case of two similar contracts in a year completed/executed value not less than **Rs.94.48 Lakhs** each.

**OR**

(c) In case of three similar contracts in a year completed/executed value should not less than **Rs. 75.58 Lakhs** each.

2. Average annual turnovers of the bidders should be more than 30% of estimated cost i.e. **Rs 56.69 Lakhs** in the last three financial years 2015-16, 2016-17, 2017-18

3. The bidder should have independent valid PF code No. and ESIC registration.

4. The bidder should have PAN.

5. The bidder should have GST Registration No.

6. The bidders shall have to submit "No suspension certificate "on his letter head.
