The Qualifying Requirements for subject work shall be as following:

1. The Bidder has to submit EMD of value ₹. 1,50,200/-.
2. The average annual financial turnover of the bidder during the last three years ending 31st March of the previous financial year should be at least ₹. 22.52 Lacs.
3. Bidder should have successfully completed / executed Horticultural work (s) during the last seven years ending last day of month previous to the one in which applications were invited, either of the following:
 - a) In case of single Horticultural Work Contract completed / executed value not less than ₹. 60.05 Lacs i.e. 80% of Estimated Cost.
OR
 - b) In case of two Horticultural Work Contracts completed / executed value not less than ₹. 37.53 Lacs each i.e. 50% of Estimated Cost.
